## Terms and Condition

**Participation:** Participation in BBF is open to Publishers, Booksellers, Book Distributors, Dealers and manufacturers of teaching aids, Associated IT segment, Stationery and other education-related materials, etc.

**Stall Confirmation:** Stall reservation and confirmations will be acknowledged only after full payment towards the participation fee is received on or before 15th of November 2013. Stall allotment will be raffle based so as to instill an autonomous method in participation. Application received after the last date will be entertained only subject to availability of space. It shall be the responsibility of the participants to remove all exhibits, tools and other material at the end of the festival and leave the stall in the same condition in which they were allotted.

**Regional Language Stalls:** Indian language books only should be displayed and sold at the Regional Language Stalls. English or any other foreign language books will not be allowed.

**Second Hand / Pirated Books** are strictly not allowed to be sold at the Bangalore Book Festival and if found selling the same will be seized and a penalty of Rs 5000 will be levied and the fair authorities will have the right to vacate the stall from the premiss.

**Uniform Discounts:** A Uniform Discount of 10% should be allowed on sale of books to all customers at the festivals.

**Possession/Vacation of Stalls:** Participants will be given the possession of stall from the 28th Nov 2013 from 11:00 hrs. The stalls should be vacated latest by 16:00 hrs on 9th Dec 2013, failing which organiser shall have the right to remove the exhibits/materials at the risk and cost of the participants.

**Encroachment of Passages:** Stall owners, sponsor, etc shall not encroach into the passages which are solely ment as walkways for the visitors.

**Upkeep and Cleanliness:** The organiser though would be responsible for the upkeep and cleanliness of the festival area; responsibility of the cleanliness in the individual and stall would be of the individual participants.

**Display of Banners, Posters etc:** There will be no restriction on the display of banners, posters etc within the stall. However nothing will be allowed for display over and above a height of 8 feet.

**Playing Audio/Video Cassettes/CD's:** Participants playing Audio, Video Cassettes/ CD's/ VCD's/DVD's etc at the stall should ensure that the level of sound does not cause any inconvenience to either the neighboring participants or to the visitors. The fair authorities will have the sole discretion on these matters.

**Insurance:** It is the responsibility of the participants to insure their exhibits and stock against break-ins, damages by fire and water, natural disasters, terrorist strikes, unprecedented happening and any other unspecified reason during transit to and from the exhibition halls as well as during the duration of the festival. The organiser will not bear any responsibility in this regards. However the organiser will insure each stall for a sum of Rs. 1 Lakh.

**Security:** While the organiser will make round the clock security arrangements for the entire festivals area during BBF, neither the organiser nor the fair authorities are liable for the loss / damage / theft to the goods and property of the participants during the festival duration.

**Entry:** Participants will be allowed entry into the stall from 10:30am onwards and shall vacate the stall latest by 8:30pm every day. The participants will be given three entry passes per stall. No goods or display may be removed from the stalls without the permission in writing from the organizers.

**Postponement:** In the event torrential rain or any un-foreseen and un-precedent change in the weather conditions the festival shall be postponed to about 90(Ninety) days from the "to be" commencement of the festival, scheduled.

**BBF Schedule alterations:** In the event of natural disaster or if circumstances so warranted, the organiser reserve the right to postpone, alter or cancel the BBF. In case the fair is cancelled before the inauguration, rent collected shall be refunded after making the necessary deductions. However no refund will be made if a participants wishes to withdraw from the fair after booking.

BBPA reserve the right to accept or reject any application without assigning any reason.  
BBPA also reserve the right to change any of the terms and conditions mentioned above.

**Legal binding:** Any of the terms and conditions mentioned above might be relaxed or modified at the sole discretion of the organizing committee, whose decision will be final and binding. All matters are subjected to jurisdiction to the Honorable Courts of Bangalore City.
